# Property

The property comprises an end of terrace retail unit with a glazed frontage located at the Lincoln Road entrance into the Hykeham Green shopping centre. Internally the unit has been fitted out to a decent standard, with painted plastered walls and ceilings and a carpeted floor.

To the rear of the unit there is disabled WC and a small staff storage/ kitchen area.

### Accommodation

# **Town & Country Planning**

We understand that the property has consent for use as a betting office, a Sui Generis use within the Town and Country Planning (Use Classes) Order 1987 (as amended) in 2020

However, a change of use to any use falling within Use Classes formerly known as A1 (Shops), A2 (Professional & Financial Services), A3 (Restaurant & Cafés), D2 (Assembly & Leisure), represent a permitted change without the need to secure planning permission.

#### Tenure

The property is available **To Let** by way of a new lease, for a term to be agreed, drafted on the equivalent of Full Repairing and Insuring terms.




# Location


The property is situated at the main vehicular and pedestrian access into The Hykeham Green Shopping Centre which is located on Lincoln Road, within the North Hykeham area of the wider Lincoln City area. North Hykeham is a large town lying approximately 5 miles to the south west of Lincoln city centre.

It offers a good range of shopping and educational facilities and is a popular residential location. The A46 Lincoln bypass is located a short distance to the south.


