Property

Constructed in 2018, the property comprises a mid-terraced industrial unit of steel portal frame construction, with part brick elevations surmounted by insulated corrugated metal sheet cladding and a similarly pitched sheet clad roof.

Internally, the property benefits from the following:

- Clear workspace with minimum working heights of 5.4m
- Warehouse lighting
- Power points
- DDA compliant WC
- Kitchenette facility
- 3 phase power supply
- Fire and intruder alarm systems
- Heating and cooling system

Externally, the unit benefits from separate vehicle and pedestrian access, with vehicular access being via an electric roller shutter door (3.6m width x 3.59m height).

The unit also benefits from 5 associated parking spaces.
