Property

The property comprises a terraced ground floor retail unit that befittingly overlooks the centre's car park.

Internally the retail unit, previously a sweets and cards shop, is fitted out to a good level. The shop benefits from LED panel lighting and CCTV.

The Unit also benefits from a toilet and staff room area towards the rear.

Accommodation


Legal Costs
